Dear Ms. Sindt:

Thank you for your letter of April 28, 1995, informing us of the additional amounts owed with respect to our qualification to do business in the state of Florida. Enclosed please find our check for \$400, which covers the annual report fees for the 1993 and 1994 years.

We would, however, respectfully request abatement of the \$500 per year penalty associated with those filings. We are not in dispute over the annual report fees, but believe we had reasonable cause for the defect.

Werner Enterprises, Inc. is a large interstate common truckload carrier which operates in the 48 contiguous states and Canada. Our intrastate business within Florida, during the years in question, is diminimus in relation to our entire fleet operations. We believed we were operating under the exemption provided for transacting business in interstate commerce.

Unfortunately, we were not aware of Florida law regarding the requirements for qualifying to do business. With the complexity and the diversity of state laws, we often have to rely upon state agencies, such as yours, to assist us in identifying these types of issues. As soon as the need for qualification was brought to curattention, we immediately responded to rectify the defect.

As evidenced by our other filings with the state, such as income and fuel tax, we showed a good faith effort to comply with state laws. We made our presence known and timely paid the associated tax due.

For these reasons, we would respectfully request abatement of the penalty associated with these filings. If you have any questions, or if additional information is required, please contact me.


