**ARTICLE OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
FOR  
OVERSTREET EQUIPMENT SALES, INC.**

Pursuant to the provisions of the Alabama Business Corporation, Act, the undersigned hereby adopts the following Articles of Amendment.

**ARTICLE I**

The name of the corporation, before amendment, is OVERSTREET EQUIPMENT SALES, INC.

**ARTICLE II**

The following amendment was adopted in the manner provided for by the Alabama Business Corporation Act.

The name of the Corporation shall be changed as follows:

OVERSTREET EQUIPMENT, INC.

**ARTICLE III**

The amendment was unanimously adopted by the shareholders and directors in the manner prescribed by law on January 6, 1999.

**ARTICLE IV**
