Thank you for your letter dated April 25, 1994, concerning the "Application by Foreign Corporation for Authorization to Transact Business in Florida", for. Arlington Beaches Water Treatment Systems, Ltd..

Please be aware that this office administers the "Florida Business Corporation Act", Chapter 607, Florida Statutes, which governs domestic and foreign corporations in Florida. The above referenced application that was submitted to this office by Arlington Beaches Water Treatment Systems, Ltd., states April 1, 1984, as the date first transacted business in Florida. Section 607.1501(1), F.S., authority of foreign corporation to transact business required, states that "a foreign corporation may not transact business in this state until it obtains a certificate of authority from the Department of State". Accordingly, this office is required by law to notify and collect the appropriate minimum civil penalty of \$500 for each year or part thereof that a foreign corporation transacts business in Florida without authority, along with the annual report fees that would have been paid had it qualified when it first transacted business, as set forth in s. 607.1502(4), F.S., consequences of transacting business without authority.

This office had no prior knowledge that Arlington Beaches Water Treatment Systems, Ltd. was transacting business in Florida without authority until it received the application.

The Division of Corporations exchanges information with the Florida Department of Revenue, pursuant to s. 213.053(14), F.S.. The information obtained from the Florida Department of Revenue relates to corporate taxpayers that are not on file or have a dissolved status with the Division of Corporations and which have filed tax returns pursuant to either Chapter 199 (intangible personal property taxes) or Chapter 220 (corporation income tax).

In July of 1993, this office received data reflecting Arlington Beaches Water Treatment System's compliance with Florida's revenue laws. On January 14, 1994, this office wrote Arlington Beaches Water Treatment Systems, Ltd. inquiring as to whether it needed a certificate of authority to transact business in Florida within the meaning of s. 607.1501, F.S.. This office then received the "Application by Foreign Corporation for Authorization to Transact Business in Florida", for Arlington Beaches Water Treatment Systems, Ltd., reflecting April 1, 1984, as the date first transacted business in Florida.

Please also be aware that Florida law does not grant this office authority to waive or dismiss any civil penalty or annual report fee due this office. This office is sympathetic to your situation and does not question Arlington Beaches Water Treatment System's honorable intention to comply with a variety of filing requirements and laws in the State of Florida. I regret that this corporation did not apply for and receive authority prior to conducting business in Florida as required by law, and unfortunately, this office may not consider any factors other than the information as set forth on its application.

If you review and determine that the referenced date is erroneous within the meaning of s. 607.1501, F.S., you may provide this office with a sworn affidavit correcting such date.

Dear Ms. Lott,

My name is Ken Wilkinson. I have several questions.

1. What is the INTENT of imposing such severe fines and penalties as written into Fla. statute 607.1501, 607.1502 as (or if) it applies to me. Do you pre-judge that I have been intentionally trying to avoid paying a yearly registration fee. This is far from the case.

As of Jan/14/1994, when I received your first letter, I was totally unaware of such a filing requirement and fee. It was only through your letter and attached copy of Fla. statutes (1991) that I have learned of this filing requirement. The letter starts out: Based on a comparison of data provided by the department of revenue...

2. Why did you not contact me back in 1984 when I first filed a corporate income tax report with the state?

I have a record of timely filing all tax returns, forms, fees and licenses that are regularly sent to me. These include Federal and state income tax, intangible tax, tangible tax, sales tax and payroll taxes. In addition, all city licenses and permits are filed on time. All of my bills from the vendors that I deal with have been paid in full and on time. There has been no conscious effort by me to hide my business dealings and transactions in Florida!.

I believe it would be wholly unfair for you to impose a 500 dollar penalty per year on me based on this and the following information.

I am totally and physically disabled due to an accident at age 17. The injury left me as a quadriplegic. However, I managed to complete high school despite my disability. I went on to collage and earned a BS degree in business/accounting. I used this education to open and manage a small business here in Jacksonville Florida. But now I have to face the prospect of closing my business and turning to social security benefits because of what?. An oversight by me in failing to file a registration form and accompanying fee.

I simply do not feel that such a severe penalty is justified because:

(1) My failing to file was unintentional. (2) I have been barely making ends meat over the last 5 years (see attached summary of operational losses). Such a fine would put me out of business. (3) I have no valuable assets to sell off or for you to put a lean against (see attached disclosure of assets). (4) My disability. t

takes all of my strength just to sit and write this response (see attached doctors note). The letters sent by your office to me have caused me a lot of physical pain and anxiety in responding to them. I will close my business rather than contest your claim in court.

Ms. Lott, let me also state, however, that I have no qualms against paying yearly charter taxes and report fee. I have demonstrated all along my attention to the requirements of the IRS, Florida Dept. of Revenue and the City of Jacksonville in filing all of the tax documents and forms provided me. And in a timely

Once again, I was not aware of your form titled: Application by a foreign corporation for authorization to transact business in

Florida (or the statutes that accompany it).

With this in consideration, I ask that you waive all interest and penalties and accept the accumulated charter tax and annual report fees as payment and settlement of this matter.

Based on a review of the file and the financial information provided this office by Mr. Wilkinson, it is my recommendation that this file be closed and all outstanding penalties be abated. The corporation has incurred an operating loss for each of the last five years and has limited assets. Furthermore, its president is a quadriplegic who himself appears financially incapable of paying the full outstanding amount of \$5821.25 in fees and penalties. Consequently, it is my recommendation that this case be settled following payment of \$1021.25 for the outstanding annual report fees.
