Based on a review of the file and the decision filed by the First District Court of Appeals in *Martnair Freight Forward, Inc. v. Florida Dept. of Commerce*, 419 So. 2d 1136 (Fla. 1st DCA 1982), it is my opinion that all penalties and fees be abated, and this corporation be permitted to qualify to do business in this state. The factual scenario of this case is directly on point with the above cited case. MATIS merely participated as a bidder for a governmental contract in 1994. It was subsequently awarded with the bid and entered into a contact in October, 1994. The services detailed in the contract were not to be performed until 1995. Given the *Martnair* precedent, MATIS is not required to register until this year. Consequently, all fees and penalties should be abated, and MATIS permitted to qualify in this state.
