Mr. H.F. Ford, President of the above-referenced corporation, asked that I contact you in response to your letter dated April 3, 1995 regarding the imposition of penalty fees in connection with the corporation's Application by Foreign Corporation for Authorization to Transact Business in Florida.

We would respectfully request that any such penalty fees be waived as the company was in no way attempting to avoid registration or avoid paying the annual fee.
