As it has just been brought to our attention that we, in all probability, are required to get authorization as a foreign corporation to transact business in Florida, we submit the enclosed application along with the required fee.

We are requesting penalties that we might be subjected to since 1990 be withdrawn as we were unaware that we needed to be registered as a foreign corporation in the state of Florida until January, 1995. As you will find, we have tried very hard to pay all taxes and file all returns that we knew were necessary. We have always paid corporate income taxes and sales taxes and mailed returns as required. We have also been audited by the State of Florida for corporate taxes and sales tax, but no one mentioned to us that we needed to be registered as a foreign corporation.
