This is in response to your letter dated February 9, 1995, requesting that the penalty fees, imposed against Bret Enterprises, Inc. for transacting business in Florida without having the authority to so, be abated or waived by the Department of State.

It does not appear from your correspondence that there is a compelling reason for this office to waive the penalty fees imposed against Bret Enterprises, Inc. for unlawfully transacting business in Florida.

The Division of Corporations recognizes that Bret Enterprises appears to have complied with various Revenue laws. However, it is the responsibility of each foreign corporation to comply with all the appropriate laws that govern it. Florida law requires that a foreign corporation receive authority from the Florida Department of State prior to transacting business. If a foreign corporation transacts business in Florida without authority, then it is liable for past annual report fees and civil penalties pursuant to s. 607.1501, F.S. (copy enclosed).
