THIS LETTER IS TO INFORM YOU OF THE SITUATION WITH EUROSPORT MARINE TRANSACTING BUSINESS IN THE STATE OF FLORIDA. IN SEPTEMBER OF 1992 I SPOKE WITH AN ATTORNEY MR. CHRISTOPHER PATTERSON TO INCORPORATE EUROSPORT MARINE. HE ADVISED ME TO GO WITH A FOREIGN CORPORATION DOING BUSINESS IN THE STATE OF FLORIDA DUE TO ONE OF OUR OFFICERS BEING FROM FRANCE. AT THAT TIME MR. PATTERSON HAD ALREADY SENT IN AN APPLICATION FOR THE NAME EUROSPORT MARINE PRODUCTS, INC. HE REFERRED ME TO REGISTERED AGENTS, LTD. IN DELAWARE, ON SEPTEMBER 3RD 1992 I PAID FOR AN INVOICE THAT CONSISTED OF A COMPLETE INCORPOR-ATION PACKAGE: HOME STATE REGISTRATION, CERTIFICATE OF GOOD STANDING, AND STATE FILING FEES (FLORIDA). THE INVOICE TOTALED \$590.00. AT THIS TIME I WAS TO BELIEVE THAT REGISTERED AGENTS WAS HANDLING THE INCORPORATION OF EUROSPORT MARINE, FOR THAT IS WHAT WE HAD PAID THEM TO DO. AS YOU ARE AWARE REGISTERED AGENTS DID NOT SUBNIT OUR APPLICATION UNTIL AUGUST 2, 1993. THEY AT THIS TIME TOLD ME IT WAS REJECTED BECAUSE THE NAME HAS ALREADY BEEN TAKEN. THEY ADVISED ME TO COMPLETE A NEW APPLICATION AND I HAD TO PAY ADDITIONAL FEES TO RESUBMIT. I NOW HAVE RECEIVED A LETTER FROM THE STATE OF FLORIDA THAT EUROSPORT MARINE OWES \$2,100.00 FOR TRANSACTION BUSINESS AS A FOREIGN CORPORATION IN FLORIDA WITHOUR AUTHORITY. AM VERY FUSTRATED AND CONFUSED, BECAUSE I FEEL I HAVE DONE EVERY THING THAT I COULD HAVE DONE AND HAVE PAID REGISTERED AGENTS ALL FEES DUE AND I FEEL THEY HAVE NEGLECTED TO PROPERLY HANDLE THIS MATTER. I HAVE ENCOLED A CHECK IN THE AMOUNT OF \$700.00 FOR PENALTY'S IN HOPES TO CLEAR THIS MATTER ONCE AND FOR ALL. I APOLOGIZE FOR THE INCONVIENCE THIS HAS CAUSED YOU. FOR IT HAS CAUSED ME THE SAME.
