I received your letter dated May 5, 1994 and wish to explain the circumstances for failing to file the Application by Foreign Corporation for Authorization to Transact Business in Florida.

Hubert Hine, Inc. was unaware of the filing requirements in the State of Florida at the time the corporation began conducting business in Florida. It was never the corporation's intent to conduct business without proper authorization. The corporation filed all Florida income tax returns in a timely fashion, a fact which demonstrates the corporation's willingness to pay its fair share of taxes.

If in fact a penalty is in order, the sum of \$2,661.25 is exorbitant and totally beyond the corporation's means. However, we ask that you consider the above circumstances and abate all penalties.

Thank you for your letter dated May 12, 1994, concerning the transaction of business by HUBERT HINE, INC. in the state of Florida.

Please be aware that Florida law does not grant this office the authority to waive or dismiss the appropriate penalty fees. This office is statutorily mandated to collect the appropriate civil penalty of \$500.00 for each year that a foreign corporation transacts business in this state without authority, which is the minimum penalty allowed by law. Section 607.1502(4), Florida Statutes, further directs the Florida Department of State to collect all penalties and annual report fees due this office and to recover such fees through an action in circuit court.

This office appreciates, and does not question HUBERT HINE, INC.'s honorable intention to comply with the filing requirements and laws of the State of Florida. We therefore request that the balance of \$2661.25 in the appropriate penalty fees be remitted to this office within thirty (30) days.


Dear Mr. Nevarez:




