LIFETIME FITNESS & REHABILITATION, INC. A CLOSE CORPORATION

FIRST: The man is it the corporation is:

LIFETIME FITNESS & REHABILITATION, INC.

SECOND: Its registered office in the State of Delaware is located at 25 Greystone Manor, Lewes, DE 19958-9776, County of Sussex. The registered agent in charge thereof is Harvard Business Services, Inc.

THIRD: The purpose of the corporation is to engage in any lawful activity for which

corporations may be organized under the General Corporation Law of Delaware.

FOURTH: The total number of shares of stock which the corporation is authorized to issue is
