I received your January 3 letter regarding your client's transacting business in Florida as a foreign corporation.

Section 607.1501(1), Florida Statutes, provides:

(1) A foreign corporation may not transact business in this state until it obtains a certificate of authority from the Department of State.

As a result of the failure to comply with this law, your client is liable for the appropriate fees and penalties consistent with Section 607.1502(4), Florida Statutes, which provides:

(4) A foreign corporation which transacts business in this state without authority to do so shall be liable to this state for the years or parts thereof during which it transacted business in this state without authority in an amount equal to all fees and taxes which would have been imposed by this act upon such corporation had it duly applied for and received authority to transact business in this state as required by this act. In addition to the payments thus prescribed, such corporation shall be liable for a civil penalty of not less than \$500 or more than \$1,000 for each year or part thereof during which it transacts business in this state without a certificate of authority. 
