Confirming my telephone conversations with your office, please be advised that we are General Counsel of Seatec Systems, Inc (Seatec). Seatec filed an Application by Foreign Corporation For Authorization to Transact Business and failed to fill out a date in line 6. Apparently, in response to this oversight, your department assessed Seatec for all years in which it was filed with the Department of Revenue. Seatec registered with the department of Revenue at the time of its incorporation, however all principal activities in its early years occurred outside the United States.


