Dear Mr. Dickenson:

Pursuant to your letter of September 25, 1995 and our telephone conversation this morning, I am enclosing Environmental Lighting Concepts, Inc.'s ("Company") corrected Application by Foreign Corporation to Transact Business in Florida together with the sworn Affidavit and original Certificate of Good Standing from the State of Maryland Department of Assessment and Taxation. The corrected application provides for original signatures and a brief description of the nature of the business as required in your letter.

As we discussed, the Company erroneously indicated that it first transacted business in Florida on October 30, 1989. The sworn Affidavit contains the correct date. The Company distributes lighting fixtures manufactured in the Orient. The nature of its operation, however, does not constitute transacting business in the State of Florida as defined in the Florida Statutes since the orders received are shipped out of state. However, in 1994 the Company entered into an agreement with Office Depot to provide Office Depot locations throughout the United States with lighting fixtures. While this agreement arguably falls within the exemption

under 607.1501(2)(i) Florida Statutes since the Company is essentially engaged in business in inter-state commerce, some of the locations may have been located in Florida. Consequently, we are unclear as to whether the Company required a Certificate of Authority to transact business in the State of Florida for any lighting fixtures delivered to the Office Depot locations in Florida. Inasmuch, since it is vital to our client that it receive authorization to transact business in the State of Florida as expeditiously as possible, we are submitting the sum of \$1,200.00 to you to cover the penalty and cost of filing for 1994. We understand that in the event your legal counsel finds that the agreement with Office Depot does fall under the exception for transacting business in inter-state commerce, the Company will receive either a credit or a refund.
