Please be advised our office represents Performance Development, Inc. We have received a copy of your notice of September 20, 1995, assessing a \$2,400.00 penalty. We must say we are quite upset to receive the same.

The Corporation began doing business in Florida in January, 1994. We immediately contacted your Department to determine what was required to put them in good standing. We were told the Corporation could not register under the name Performance Development, Inc., due to the fact that the name was already being utilized in the State. We were informed they could adopt an Assumed Name of PDI and register on that basis.

Based on the representations of the State of Florida, we immediately proceeded to adopt that Assumed Name and attempted to then register with State of Florida under the name PDI, pursuant to Florida's instructions. The State of Florida then rejected the registration (Ref. #W94000012483). We have spent a lot of time conversing back and forth with the State of Florida, since that time. In addition, our client also did so on his own. Those conversations resulted in the most recent attempt to register, which now has also, apparently, been rejected and resulted in your correspondence assessing a penalty. I have enclosed copies of the correspondence in question, which verify the above statements. Inasmuch as my client acted in good faith and in accordance with the advice and instructions of your Department, we do not believe a penalty should be assessed, due to reasonable cause.


