This letter confirms our telephone conversation on March 10 with respect to your February 14 letter to Michael Mays, Corporate Specialist, Division of Corporations. You requested he advise you as to whether Fox Ridge Farm, Inc. (Fox Ridge) is required to pay penalties and fees of \$6,331.25.


As discussed, it appears that Fox Ridge's activity in Florida requires qualification with the Department of State. Although Fox Ridge's transportation of its horses from New York to Florida is interstate commerce, the act of entering those horses in thoroughbred races in Florida is not. It is this activity that requires qualification. As a result, Fox Ridge is required to qualify and must submit payment of \$6,331.25 for penalties and fees for transacting business in Florida without authority.
