In answer to your letters regarding the penalty of \$7,671.25 in appropriate fees and penalties concerning failure of filing for certificate of authority prior to transacting business in the State of Florida. We feel that the assessment of the penalty of \$7,671.25 is unfair and would put a financial burden on our company. We also feel that the penalty is unfair because we were not aware of this requirement. In dealing with outside Professional and legal advisors, on such filings and failing to receive notices from the State concerning this requirement, it was absolutely unheard of previously. Storage & Handling Equip., Inc. has completed requirements as to Sales tax, Corp. Inc. tax each year under our FEIN# 25-1263615 since 1979. To this, we would like to be advised why it has taken close to 14 years to notify us of this requirement since penalties are calculated over this period. If we were notified of this requirement like we were notified about all others, the penalty would not be so high and we would have paid on time.

Please be advised that it is the responsibility of each foreign corporation to be aware of the laws which govern it. The Division of Corporations was not aware of STORAGE & HANDLING EQUIPMENT INC. activities in Florids prior to 1993. The Division of Corporations received information from the Florida Department of Revenue, pursuant to section 213.053(14), Florida Statutes. That information relates to corporate taxpayers which are not on file or have a dissolved status with the Division of Corporations, and which have filed tax returns pursuant to either chapter 199 (intangible personal property taxes) or chapter 220 (corporation income tax). In July of 1993 this office received data reflecting STORAGE & HANDLING EQUIPMENT INC.'s compliance with Florida's revenue laws. On November 24, 1993, this office wrote STORAGE & HANDLING EQUIPMENT INC. inquiring as to whether it needed a certificate of authority to transact business in Florida.

This office then received the "Application by Foreign Corporation for Authorization to Transact Business in Florida", for STORAGE & HANDLING EQUIPMENT INC., reflecting June 15, 1979, as the date first transacted business in Florida. This office had no prior knowledge that STORAGE & HANDLING EQUIPMENT INC. was transacting business in Florida without authority until it received the application.

I regret that STORAGE & HANDLING EQUIPMENT INC. did not properly obtain authority as required by law. Any foreign corporation that desires to become lawfully authorized to transact business in this state may contact the Division of Corporations to request the proper application, instructions and filing fees, and receive personal assistance in the filing of such documents. The Division

of Corporations also provides copies of the Florida Statutes that govern foreign and domestic corporations in Florida. Again, I emphasize that it is the responsibility of each foreign corporation to be aware of the laws which govern it and to obtain proper authority prior to conducting business when the activities of such corporation consitute the "transaction of business", as defined by s. 607.1501, F.S. (copy enclosed).

This office appreciates, and does not question STORAGE & HANDLING EQUIPMENT INC.'s honorable intention to comply with the filing requirements and laws of the State of Florida; however, it does not appear from your correspondence that there is a compelling reason for this office to waive much penalties. This office is statutorily mandated to collect the appropriate civil penalty of \$500.00 for each year that a foreign corporation transacts business in this state without authority, which is the minimum penalty allowed by law. Section 607.1502(4), Florida Statutes, further directs the Florida Department of State to collect all penalties and annual report fees due this office and to recover such fees through an action in circuit court. We therefore request that the \$7671.25 in the appropriate penalty fees be remitted to this office within thirty (30) days.


