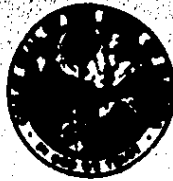

Dear Mr. Collins:

In response to your letter Number 395A00049209 To Sandra Doupe' who serves as the accountant for Jesse Jones and Associates. Jesse Jones and Associates, Inc. has not transacted any business whatsoever in the State of Florida. I submit herewith copies of the recorded Fictitious name affidavit which shows the company to be a partnership between my wife and myself. I also submit herewith a copy of my application for a Lee County Occupational License dated 11-19-1993 showing the company to be a partnership. I very recently moved to Sarasota County and submit herewith a copy of my Sarasota County Building Contractor Certification in the name of Jesse Jones and Associates which continues to be a partnership.

It is my intention to begin doing business as a corporation upon receipt of my permission to do so from your office.

My wife and I moved to Florida from Texas in 1989. We first resided in Naples and did business as Jesse Jones and Associates in Collier County. In 1993 we moved to Lee County and again did business as Jesse Jones and Associates. Our accountant, at that time, was a Mr. Harry Platzer, who resides in Texas. Mr Platzer reminded us that a rather large loss-carryforward existed in our Texas Corporation, Jesse Jones and Associates, Inc. and advised us to retain a Florida C.P.A and file tax returns in the name of the Corporation in order to maintain, and eventually be able to take advantage of the losses we had incurred in Texas. We submitted returns through a Collier County C.P.A. in the name of Jesse Jones and Associates, Inc. with the sole purpose of maintaining a continuing business participation situation for the corporation so that we would not lose the loss-carryforward we had incurred in Texas.

I respect the laws of the State of Florida and would never, knowingly, violate any one of them. I have never done business in Florida as a corporation, nor do I intend to do so, until I receive permission and certification from your office.

I hope this information will allow you to file our affidavit to do business in Florida as a Corporation. Should you need further information from me, I will be happy to provide it.
