This is in response to your letter dated June 22, 1995 regarding the above subject. A copy of this letter is attached for your convenience. Although there is no detail of what comprises the \$ 2,100 due reflected in the third paragraph of your letter, it appears to represent \$ 1,500 in penalty fees and \$ 600 for Annual Report fees.

We are requesting that the penalty fees be abated for the following reasons:

- 1) The company has acted in good faith in filing its Corporate Income/ Franchise Tax return in Florida once it started business there.
- The company acted in good faith in recently completing the Application by Foreign Corporation for Authorization to transact Business in Florida once it became aware of the need to do so.
- 3) The company was not aware of a need to file an Application for Authorization because it was assumed it was not necessary to be authorized because of the type and minimal degree of activity in Florida, plus it never received any information from Florida regarding a possible need to become authorized until 1995. The company's sole business activity in Florida consists of renting one warehouse which has resulted in an average tax liability of \$ 3,500 in the state.



The responsibility to pay the annual report charges is acknowledged by the company, but the penalty appears excessive in light of the facts above. Please give our request for abatement appropriate consideration. If you should need any further information please contact me.
