On September 11, 2001, Deutsche Bank and many of its affiliates occupied approximately 3.4 million square feet of office space at 130 Liberty Street, New York, New York ("130 Liberty Street"). 130 Liberty Street served as the principal back office and support location for many of Deutsche Bank's operations in the United States. 130 Liberty Street was located across Liberty Street from the World Trade Center complex. As a result of the terrorist attacks on the complex and the collapse of the World Trade Center, 130 Liberty Street sustained substantial structural damage: much of the north face of the building below the 23<sup>rd</sup> floor was exposed to the elements, hundreds of windows were broken throughout the building, the roof was damaged and World Trade Center debris was distributed throughout the building. The months of fires and cleanup activities at Ground Zero further subjected 130 Liberty Street to smoke and other contaminants moving through the entire building. The building also sustained fire damage and water damage during the period from September 11 through mid- to late-December when Deutsche Bank was allowed to re-enter the building.

Currently, 130 Liberty Street may only be entered by personnel fitted with respirators and double protective suits because of the confirmed presence of numerous toxic substances in the building. There is no functioning air conditioning or ventilation system in the building, and only emergency and construction electric power is available. 130 Liberty Street is a construction work site, and many areas of the building are missing floors and are otherwise structurally hazardous.

We have instituted a systematic environmental analysis to determine the types and levels of hazardous contaminants in the building. Preliminary environmental testing results are now available to us. Our consultants have advised us that, based upon this preliminary data, 130 Liberty Street and its contents have been contaminated with a number of toxic substances. The types of contaminants vary by floors of the building and by areas on each floor, as does the level of each contaminant. We have not yet determined to what extent we can successfully remediate the building (if at all) or its contents. To the knowledge of our consultants, no one has ever successfully decontaminated an office building containing the variety and levels of contaminants in 130 Liberty Street. Our toxicologist and hygienists have indicated that the contaminants in 130 Liberty Street pose a threat to human health and that the current body of scientific knowledge is not sufficient to give us specific guidance on the proper method to remediate the building and its contents to make it safe for human use as an office building.

Given this situation, we have determined that our institution will make every reasonable effort to prevent unnecessary contact by unprotected persons with the contents of 130 Liberty Street. The building contains tens of millions of pages of contaminated paper. After carefully considering all the options with respect to the paper remaining in the building, we have decided

that in order to protect our employees and the public, the best and only prudent decision is to destroy virtually all the remaining paper in the building. We have been able to operate our business without access to the paper in the building for almost one year. Thus we believe this is also a prudent decision from an operational perspective.

Our decision will result in the destruction of records that we may be required to maintain under laws and regulations under your jurisdiction, or because of ongoing investigations. You should note, however, that electronic records were largely backed up and were recovered promptly after the events of September 11. Those records are not the subject of this letter. We have discussed our conclusions with our principal U.S. regulators, the Federal Reserve Bank of New York and the State of New York Banking Department.

A list of the functions and entities located at 130 Liberty Street at the time of the World Trade Center attacks and a list of our active entities in the United States that were serviced by the units located at 130 Liberty Street are attached to this letter for your convenience.
