Pursuant to section 607.1404, Florida Statutes, SEITLIN & COMPANY, a Florida profit corporation, hereby revokes its Articles of Dissolution prior to the expiration of 120 days following the effective date of the Articles of Dissolution:

FIRST: The name of the corporation is Seitlin & Company (referred to below as the "Corporation").

SECOND: The Corporation's Florida Document Number is F95713.

THIRD: The effective date of the Articles of Dissolution filed with the Florida Department of State is March 12, 2012.

FOURTH: Neither the Board of Directors of the Corporation, nor the Shareholders of the Corporation, authorized the Corporation's dissolution with the State of Florida. Revocation of the Articles of Dissolution is permitted by action of the Board of Directors.
