Dear Ms. Lott:

As we have discussed, we are enclosing an original and one copy of the Application by Foreign Corporation for Authorization to Transact Business in Florida, including the required certificate of existence from the New York Department of State, for the above referenced corporation.

Our client failed to qualify to transact business in Florida in previous years. The Division of Corporations has been instructed to assess the maximum penalties against the corporation (\$1,000 per year for four years). We are requesting a review of this filing by the General Counsel's Office inasmuch as our client is requesting that the minimum penalty (\$500 per year) be assessed pursuant to Section 607.1502(4), Florida Statutes. We believe our client's position is reasonable based on its limited ability to pay the penalties. In this regard, and as you have requested, we are enclosing copies of our client's last five (5) U.S. Income Tax Returns (1990 through 1994) to support this request for abatement with respect to the statutory penalties.

We are also enclosing our client's check made payable to the Florida Secretary of State in the amount of \$2,878.75. This amount reflects the penalties assessed for transacting business during 1991, 1992, 1993 and 1994 (\$500.00 per year) as well as the annual report fees required for the years 1992, 1993, 1994 and 1995. The December 27, 1995 Page 2

remaining \$78.75 is for the filing and registered agent fees as well as for obtaining a certificate of status to evidence the filing.

It is our understanding that it is unlikely the General Counsel will reach a decision on this matter prior to the end of the year. However, you have indicated that there will be no additional penalties assessed as long as our request is made during 1995.

If there are any questions regarding this matter or if our understanding that no additional penalties will be assessed is incorrect, please let us know. Please notify the undersigned as soon as a determination has been made regarding our request. Thank you for your assistance.


