In response to your notice dated June 28, advising that the 1999 Florida Annual Report for Kellstrom Industries, Inc. has been received, but not filed due to a pending \$400 balance, please note that this form was inadvertently filed after its due date.

Until my date of hire a few weeks ago, no one was solely responsible for the company's day-to-day tax-related matters. As such, items including the filing of our Annual Reports did not receive the proper attention until after their deadlines.
