## To whom it may concern:

On April 25 of 1997, I personally mailed the 1997 Annual Report, along with a check for \$165.00 from the account of my daughter Kelly McKernan. The check # was 111, also dated April 25, 1997. The report would not fit through my fax copier without damaging the report itself and since I am a disabled Miami firefighter, it is difficult for me to drive and get around, therefore I did not retain a copy of the report.

Upon receipt of the enclosed annual report I immediately called your offices to inquire as to what had happened and what should I do. The corporation is not actively making money as yet and I have been on a disability pension since 1973 and cannot afford such a penalty for late filing, particularly since I mailed it on time and it was apparently lost in transition somewhere along the line. I have checked my statement monthly since I mailed the original report, I assumed you were just behind in your bank deposits, I called the bank personally on Friday and have been advised that the check has never been deposited or cleared.

I spoke to a young lady in your office (904-488-9000) and she advised me that this has happened to several other people as well and that she was advising people to make out a check in the amount of \$165.00 and mail it in along with a letter explaining the circumstances. I certainly hope she is correct and that this mailing is satisfactory to your requirements.

I am again personally mailing this report, this time I am registering with the Postal Service and requesting a return receipt. I will continue this process in the future which should eliminate any further problems. I apologize for whatever inconvenience you have suffered and thank you for your assistance and consideration in this matter.
