1. I am an adult resident of the State of Wisconsin, and have been an officer of **Desert Aire Corp.** ("the Corporation") since October 19, 1990. Since that date, I have held the position of President of the Corporation on a continuous basis.
2. I make this affidavit in support of and in conjunction with the Corporation's Application for Authority to Transact Business in Florida.
3. As President of the Corporation, I am familiar with the daily business activities of the Corporation, both in the State of Wisconsin and in other states, including Florida.
4. Prior to August of 1995, the Corporation did not "transact business" in the state of Florida, as that term has been explained to me by my attorneys. 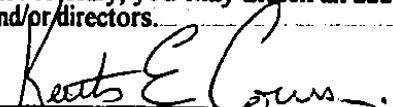
