Hopefully by the time you receive this letter, you and I will have spoken. Be advised that I represent the referenced client, seeking authorization to do business in the State of Florida.

I am in receipt of your letter dated December 21, 1995 (letter number 295A00055041), copy enclosed.

Your comments are appropriate but for the fact that I am advised by the client that the causation of this problem arises from a scrivener's error in the Application. More precisely, question number 6 was answered January 1, 1994 when in fact it was intended to be answered January 1, 1996. In fact, the client is negotiating to rent space in Tampa, intending to open an office in Florida which was the reasoning for the Application in the first place.

The January 1, 1994 erroneous date was perceived as the date first transacting business anywhere as opposed to in Florida specifically. Please note that the client was first incorporated the end of December 1993 in Tennessee and therefore logically first began doing business in Tennessee in January 1994.

The client intends to open for business in Florida January 1996 (coinciding with the opening of a new office in Tampa).

Your call would be appreciated. Advise me as to whether this




