

This is to reply to your letter of January 9, 1996, regarding an application submitted to the Office of Comptroller by the Sumitomo Bank.

As you know, the application filed by the Sumitomo Bank to acquire certain of the U.S. operations of the Daiwa Bank is being made for the purpose of giving support to the Daiwa Bank, which shall terminate the banking operations in U.S. in accordance with the consent orders issued by the U.S. bank supervisors. Naturally, we have no objection to this application. My reply to your inquiries is as follows.

- The Sumitomo Bank is currently in compliance with all applicable laws and regulations in Japan, including applicable minimum capital and liquidity ratio requirements, as well as anti-money laundering related laws; and
- We are satisfied with the Sumitomo Bank's overall financial soundness, including the generally satisfactory quality of their loan assets and the adequacy of provisioning policies.

The Ministry of Finance is committed to continue to cooperate with the U.S. bank supervisors in carrying out their supervisory duties.
