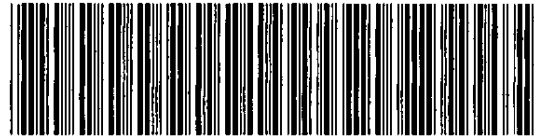

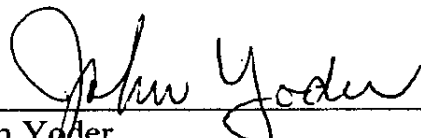
Article III The amendment was adopted by the shareholders or directors in the manner prescribed by law on March 27, 2002.
