Please be advised that Maximinus S.A. does not appear to have ever transacted business in Florida, as the same is described in §607.1501 Florida Statutes. Since the corporation does not presently intend to transact business, it will not be applying for authorization unless the law changes.

The incomplete and unsigned application you received does not legally constitute an application, and should be ignored. Nevertheless, some clarification of the factual situation is appropriate. Thank you for your letter dated September 28, 1994, concerning authority to transact business in Florida by Maximinus, S.A..

This office is unable to "ignore" the fact that Maximinus, S.A. submitted an "Application by Foreign Corporation for Authorization to Transact Business in Florida", that states that it began transacting business in Florida on April 15, 1979, without authority and in violation of Florida law. This office is responsible for notifying foreign corporations of the consequences of transacting business in Florida without authority. This office is required to pursue the collection of the minimum civil penalties and annual report fees due this office by Maximinus, S.A.

The fact that Maximinus, S.A. owns real property that is leased to several tenants, regardless of whether it directly manages said real property is considered "transacting business", as it exceeds the provision set forth in s. 607.1501(2)(m), F.S., <u>owning</u>, without more, real or personal property". Therefore, Maximinus, S.A. is liable for the civil penalties and annual report fees totaling \$8371.25, pursuant to s. 607.1502(4), F.S..

Please remit the above mentioned civil penalties and annual report fees due this office within 30 days to avoid the necessity of further action.

Thank you for your letter of October 5, 1994. If you have a completed application form signed by an officer or director of Maximinus, S.A., kindly provide a copy. If you do not, then you have only a form, not an application.

Your position seems to be that although a foreign corporation may do any one of the specifically exempted activities, it may not do more than one of them. This is not how it works at the courthouse. In any event, §607.1501(3) provides that "The list of activities in subsection (2) is not exhaustive." If you have a specific Florida case (DCA or Supreme Court) which you can cite and which applies to this situation, kindly provide it and I will advise my client accordingly.

I have received copies of the summons and complaint delivered to the real estate broker who has dealt with Maximinus, S.A., one of the Defendants in this case. The purpose of this letter is to explore settlement; therefore, nothing contained herein should be placed before the court. This letter is not an offer that can be accepted to constitute a binding agreement.

The information provided to me shows that Maximinus, S.A. owns a commercial property in Broward County, Florida. Maximinus does not occupy this or any other property in Florida. The property has been rented to long-term tenants. All rentals and other transactions related to this property have been performed exclusively by Michael Pomponio, a registered real estate broker, on a continuing --- but event by event --- basis. Maximinus has never had any employees, officers, directors or stockholders in Florida.

I have not found an appellate decision which states that the foregoing situation constitutes transacting business within the meaning of §607.1501 Florida Statutes. If you have one, please give me the cite; so I can advise Mr. Pomponio.

Maximinus, S.A. is not one of the scofflaw alien corporations which proliferate in South Florida. The information provided shows that property taxes, sales and use taxes, income taxes and intangible taxes have been duly reported and paid. If it is required, Maximinus, S.A. will register too.
