BEFORE ME, the undersigned authority, personally appeared DAVID ABRAHAMS, who after being duly sworn, deposes and says as follows:

1. In Question No. 6 of the attached Application by Foreign Corporation for Authorization to Transact Business in Florida, Oasis Publishing Company ("Oasis") stated that it first transacted business on December 6, 1990 in Florida. This is incorrect. Since 1991, Oasis has sold its products in Florida exclusively through an independent contractor distributor named Interaction: CD-ROM & Optical Storage ("Interaction"). Interaction is not an employee or agent of Oasis.

2. Accordingly, this situation follows under an exception to Florida Statute Section 607.1501(2)(e) which states that selling through an independent contractor does not constitute "transacting business" within Section 607.1501(1).

3. The correct answer to Question No. 6, inquiring when Oasis will begin transacting business in Florida, is unknown at

this time. Oasis hopes to begin transacting business some time during the 1996 calendar year.

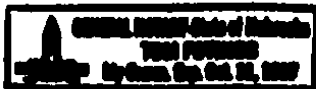

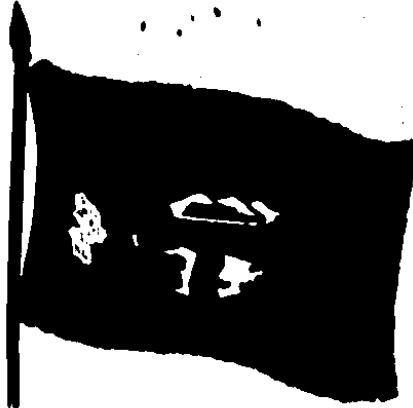

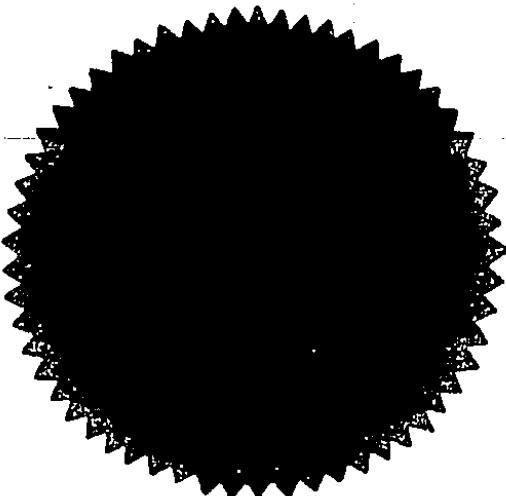
