We have enclosed the 1998 Corporation Annual Report for Lochinvar Corporation, along with our check for \$150.00.

We have not included the late fee due to the circumstances behind this late filing. We did not receive any forms from the State of Florida for 1998. No form was received for the Annual report, for the Intangibles Tax, etc. The comment received when calling your office after receiving the late notice was, "A lot of people didn't get the forms this year."

This is only the second year for our operations and filing requirements in the State of Florida. Unlike all the other states, which send forms, the State of Florida appears to be raising revenues from foreign corporations by omitting them from their mailing lists of required forms, thereby collecting late fees and penalties.
