No substantial part of the activities of the Corporation shall consist in carrying on propaganda or otherwise attempting to influence legislation. The corporation shall not participate in, or intervene in tincluding the publishing or distributing of statements) any political campaign on behalf of any candidate for public office.

Fifth: In case of the dissolution of the Corporation, subject to the approval of the Supreme Court of the State of New York, no distribution of any of the property or assets of the Corporation shall be made to any member, director, officer or employee

of the Corporation, but all of such property and assets shall be applied to accomplish the public charitable and educational purposes for which the Corporation is organized.
