RE: Request for waiver or reduction to statutory minimum

Dear Sir / Madam:

Last week, when I realized that my company was not a Florida corporation, I contacted the state on my own to rectify the situation. The following is an explanation of the events leading up to this point.

In 1994 a friend of mine and I were planning to move to Rehoboth Beach, DE and start a business consulting service. He incorporated us as a Delaware corporation in July 1994 with plans to start up the business in January 1995. Prior to transacting business, we had a falling out, he moved away, and I decided to remain in Tampa.

In late November 1994 I began to do some consulting work. I could have done it as a sole proprietor and reported the income on my 1040 but figured that since I already had the corporation set up, I may as well use it. Had I done so, this corporation problem would have never arisen.

In March 1995 I properly filed an 1120-S Federal tax return for 1994 (copy enclosed). In March 1996 I filed a similar return for the 1995 calendar year (also enclosed).

Two weeks ago I received a Florida Corporate Short Form Income Tax Return for the first time. Question B asks for the Florida Secretary of State Document Number. Upon looking through my files I realized that the corporation was a Delaware Corporation and not a Florida Corporation.

It was then that I contacted Mr. Hart Collins to find out what I needed to do to rectify the situation. Mr. Collins has sent me all the forms necessary to register as a Florida corporation. I have completed these forms and returned them with the required fees.

Mr. Collins indicated that the civil penalty could be as high as \$1000 per year. While I know that ignorance of the law is no excuse, I request that you waive or reduce this penalty for the following reasons.

- 1) When I realized the problem, I took a proactive position to rectify the situation, as opposed to your department contacting me.
- 2) There are insufficient funds in the corporation to pay the penalty.
- 3) Revenues for 1996 through March 18 have only been \$4140. Because of this downturn in revenues, I have decided to "close up shop" in the next few weeks and look for a position as an employee with another company. 1996 will be the final year for this corporation.
- 4) I was only in business for a few weeks in 1994. Had I recorded this income on my 1040 instead of the corporation, I would only have been in violation for one year, not two.

Once again, please consider waiving or reducing this penalty. Thank you for your time and consideration.

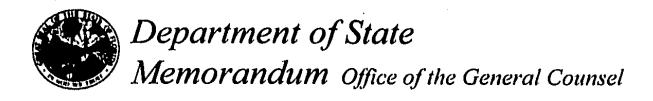
