#### ARTICLES OF INCORPORATION OF MID AM CREDIT CORP.



FIRST: The name of the Corporation shall be Mid Am Credit Corp.

SECOND: The principal office of the Corporation in the State of Ohio shall be located in the City of Columbus, County of Franklin.

<u>TIHRD</u>: The purpose for which the Corporation is formed shall be to engage in any lawful act or activity for which corporations may be formed under Sections 1701.01 to 1701.98, inclusive, of the Ohio Revised Code.

<u>FOURTH</u>: The number of shares which the Corporation is authorized to have outstanding is 1000 shares common stock, without par value.

FIFTH: The Corporation will commence business without any allocation to stated capital.

SIXTH: No shareholder of the Corporation shall have, as a matter of right, the preemptive right to purchase or subscribe for shares of any class, now or hereafter authorized, or to purchase or subscribe for securities or other obligations convertible into or exchangeable for such shares or warrants which would otherwise entitle the holders thereof to subscribe for or purchase any such share.

<u>SEVENTH</u>: Neither Section 1701.831 of the Ohio Revised Code nor Chapter 1704, of the Ohio Revised Code shall apply to control share acquisitions of the corporation.

EIGHTH: The corporation shall have the power to indemnify its present and past directors, officers, employees and agents, and such other persons as it shall have powers to indemnify, to the full extent permitted under, and subject to the limitations of, Title 17 of the Ohio Revised Code. The corporation may, upon the affirmative vote of a majority of its Board of Directors, purchase insurance for the purpose of indemnifying its directors, officers, employees and agents to the extent that such indemnification is allowed in this Article EIGHTH.

NINTH: Any and every statute of the State of Ohio hereafter enacted, whereby the rights, powers or privileges of corporations or of the shareholders of corporations organized under the laws of the State of Ohio are increased or diminished or in any way affected, or whereby effect is given to the action taken by any number, less than all, of the shareholders of any such corporation, shall apply to the Corporation and shall be binding not only upon the Corporation but upon every shareholder of the Corporation to the same extent as if such statute had been in force at the date of filing these Articles of Incorporation of the Corporation in the office of the Secretary of State of Ohio.


