Based upon information provided by the Florida Department of Revenue, pursuant to section 213.053(14), Florida Statutes, it appears that CODE BLAZERS, INC. has transacted business in Florida prior to submitting an "Application for Authority to Transact Business in Florida". Pursuant to section 607.1502(4), 617.1502(4) or 608.502(4), Florida Statutes, this office collects a civil penalty of \$1000 for each year this entity transacted business or conducted its affairs in Florida prior to qualification and the appropriate annual report fees that would have been due this office had the entity qualified the year it began operations in this state. The amount due this office to cover both annual report and penalty fees is \$2,400.00.

Dear Lee Rivers:

Please consider this the official response to the notice dated December 12, 1995 and received by the taxpayer December 20, 1995 (copy enclosed). Upon review of this notice it appears as though the date first transacted business in the state of Florida was actually January 1, 1994 as opposed to January 1, 1993 as listed. This can be documented by reviewing a copy of the enclosed **initial** form F-1120 for the year ended December 31, 1994. None-the-less, there was truly no intent to knowingly keep from paying the state its appropriate application fees for conducting business within the state of Florida.

The taxpayer has filed and paid, on a timely basis, all corporate, tangible and intangible taxes due to the respective tax bodies (copies enclosed). The fact that there was an application to complete and an application fee to pay on an annual basis for conducting business in the state of Florida was **truly** not known by the taxpayer or his advisors at that time. The taxpayer actually felt as if he were complying with all the necessary requirements to conduct business in the state of Florida by filing and paying all of the appropriate tax returns.

In light of the above it is respectfully requested that the severe penalties be abated/removed and the taxpayer be billed the appropriate application fees for the years unpaid and any associated interest that may have accrued.

Mr. Leone:

This letter is in response to your letter dated December 27, 1995. We appreciate the fact that CODE BLAZERS, INC. did not willfully choose not to file for authorization before transacting business in Florida. However, any foreign corporation that intends to transact business in this state is required to obtain a certificate of authority from the Department of State prior to transacting business as stated in section 607.1501(1), Florida Statutes:

"A foreign corporation may not transact business in this state until it obtains a certificate of authority from the Department of State."

The statute directs this office to collect the appropriate civil penalty of \$1000 for each year or part thereof that a foreign corporation transacts business in this state without authority. It is the responsibility of the corporation to be aware of and to comply with the Florida Statutes. From your letter, there does not appear to be any compelling reason for the penalty fees to be abated.

In order to change the date on your application from January 1, 1993 to January 1, 1994, the corporation must submit a sworn (notarized) affidavit, as described in our previous letter, a highlighted copy of which is attached. Based on this new date, the amount due in annual report and penalty fees is \$1200, not \$2400.
