A traumittal letter from 6 accompany both Form 3.05 and a certificate of existence may be found in Form 3.06.

Neither the articles of incorporation nor a separate registered agent form needs to be submitted to the department once a certificate of existence and Form 3.05 have been submitted.

A certificate of existence is a document from the foreign corporation's home state certifying that the corporation is organized and is in good standing under the laws of that state. The term is frequently interchanged with the terms "Certificate of Status" and "Certificate of Standing."
