

BEFORE ME, the undersigned authority, this day personally appeared Ralph E. Stringer, who, after being duly sworn, did depose and state as follows:

- 1. I am the President of Stringer Marketing Group, Inc., a Virginia corporation (the "Company"), which has qualified to do business in Florida as a foreign corporation, pursuant to an Application By Foreign Corporation for Authorization to Transact Business in Florida, a copy of which is attached hereto as Exhibit A (the "Application"), which was filed with the Office of the Secretary of State of the Department of State of the State of Florida (the "Secretary of State") on March 5, 1996.
- 2. I have personal knowledge of all of the facts set forth herein.
- 3. This Affidavit is being submitted to the Secretary of State in response to its notice dated April 29, 1996 to the Company, a copy of which notice is attached hereto as Exhibit B (the "Notice"), to amend certain erroneous information and deficiencies contained in the Application.
- 4. The Company was incorporated under the laws of the Commonwealth-of-Virginia-on-November 27, 1989. A Certificate of Existence dated May 8, 1996 executed by the State Corporation

Commission for the Commonwealth of Virginia is attached hereto as Exhibit C.

- 5. On March 5, 1996, the Company filed the Application with the Secretary of State. The Application contained certain erroneous information in Item 6 thereof with respect to the date the Company first began "transacting business" in Florida, as such term is defined in Section 607.1501 of the Florida Statutes. The Application erroneously indicates that the Company had first transacted business in Florida on November 1, 1994.
- 6. The November 1, 1994 date which was originally indicated in the Company's Application as the date the Company first transacted business in Florida was actually the date that the Company first opened a bank account. Pursuant to Florida Statute Section 607.1501(c), the sole activity of maintaining a bank account in Florida does not constitute "transacting business" within the meaning of Florida Statute Section 607.1501(1).
- 7. Based upon a review of the Company's records and activities in Florida, the actual date on which the Company first "transacted business" in Florida, as such term is defined pursuant to Florida Statute Section 607.1501, was March 1, 1995, on which date the Company first entered into a contract with a client in Florida. In October 1995, the Company set up its Florida offices and operations at 1040 Weston Road, Suite 305, Fort Lauderdale, Florida 33326, and hired personnel.

8. The Company did not transact any business or conduct any affairs in Florida between November 1, 1994 and February 28, 1995.
