This letter is in response to your April 24, 1996 letter, a copy of which is attached hereto, regarding the above named corporation.

Upon detailed review of the Application by Foreign Corporation for Authorization to Transact Business in Florida, we noted that the application had originally been prepared indicating that the date the corporation began doing business in Florida was June 26, 1989.
