Following up on my earlier letter today, please note the following additional information:

- i You advised me of a telephone number for Radach, Inc. (407) 851-8400. I called the number and spoke to a lady who told me Mr. Dennis Darmoc, that company's secretary and treasurer, was out of town until Monday. She also told me the name of Radach, Inc. was pronounced phonetically like "RADITCH" and not like "RADACK" (i.e. Radac). Accordingly, it clearly appears that Radac, which is pronounced as if it were "RADACK", does not sound like the "RADITCH" pronunciation of Radach.
- ii Radac Corporation is the owner of U.S. Trademark Registration No. 1,319,994 for Radac Corporation and design. A copy is enclosed.

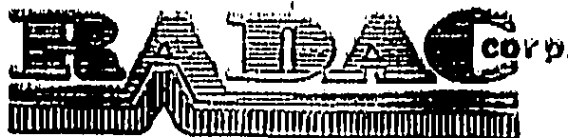
