In July, 1996 New South Insurance Company submitted to the Florida Department of State an application by a foreign corporation for authority to transact business or conduct affairs in Florida. This was done only to facilitate a license application that was filed with the Department of Insurance. Subsequently in June, of 1998 we withdrew our application from the Department of Insurance. The Company was never granted a certificate of authority and in fact has never done business in the State of Florida.
