This letter is in response to your letter dated June 9, 1994, concerning the qualification and penalty fees of Ulla Darni Galleries, Inc., considering the fact of possibly waving the penalty fee.

We appreciate the fact that Ulla Darni Galleries, Inc., has responded to our inquiry. However, each foreign corporation that intends to transact business in this state is required to obtain a certificate of authority from the Department of State prior to transacting business as stated in section 607.1501(1), Florida Statutes (copy enclosed).

This office is statutorily mandated to collect the appropriate civil penalty of \$500.00 for each year that a foreign corporation transacts business in this state without authority, which is a minimum penalty allowed by law. Florida law does not grant this office the authority to waive or dismiss these appropriate fees. Section 607.1502(4), Florida Statutes, further directs the Florida Department of State to collect all penalties and annual reports fees due this office and to recover such fees through an action in circuit court.

Again, this office appreciates, and does not question Ulla Darni Galleries honorable intention to comply with a variety of filing requirements and laws in the state of Florida. We therefore request that the penalty fee of \$1400.00 be remitted to this office within thirty (30) days.


