Purposes of Corporation

To build, maintain and operate a memorial to the late James A. Naismith, the originator of the game of basketball, including (1) a "Hall of Fame" for great figures of the game of basketball of the past, present and future and (2) a museum and library and other appropriate features devoted principally to the history and continuing development of the game of basketball; to build, maintain and operate a building or buildings for the above purposes and to furnish and equip the same and supply books, exhibits and other material and objects therefor; and generally to do all such things as will promote and accomplish the above purposes, but these purposes shall not include a right to apply for a license to sell alcoholic beverages. No profit shall inure to any member or individual connected with the corporation. Upon dissolution the then remaining net assets shall be distributed to such private charitable educational corporation or corporations in such proportion or proportions as the corporation shall determine.


