Thank you for letter of July 11, 1996, transmitted by facsimile machine, advising of the plans of T. Rowe Price Trust Company, a Maryland limited trust company, to establish a trust representative office in Florida.

Your letter indicates an understanding that the activities of the office are circumscribed by our January 12, 1992, Order of General Application regarding establishment of trust representative offices. The Order requires the office operate within the parameters set forth by the Office of the Comptroller of the Currency for national banks. Activities are essentially limited to meeting with customers, facilitation of transfer of documentation, assistance in customer communication, and solicitation of new fiduciary accounts. Day-to-day account administration and discretionary investment activity cannot be conducted in any Florida office.

Because the proposed activities are not considered to be conducting a "trust business" from a Florida office, there is no formal application or approval required by this office for establishment of a trust representative office. We have no objection to the use of the name "T. Rowe Price Trust Company" in conjunction with the proposed activity.
