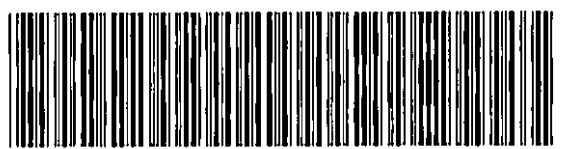



Under Section 805 of the Business Corporation Law

FIRST: The current name of the corporation is SOCATA North America, Inc. (the "Corporation"). The name under which it was originally formed is "Rallye Aircraft Corporation".

SECOND: The certificate of Incorporation of the Corporation (such certificate of incorporation, as amended or restated and in effect thereafter, the "Certificate of Incorporation") was originally filed with the New York State Department of State on June 7, 1977.


THIRD: The Certificate of Incorporation is hereby amended as follows:
