# FIRST CERTIFICATE OF AMENDMENT OF THE CERTIFICATE OF INCORPORATION OF AUTOLINERS, INC.

UNDER SECTION 805 OF THE BUSINESS CORPORATION LAW

The undersigned, being the President and Secretary of AUTOLINERS, Inc. (hereinafter the "Corporation") hereby certify:

- 1. The name of the Corporation is AUTOLINERS, INC. The name under which the Corporation was originally formed was AUTOLINERS Inc.
- The Certificate of Incorporation of the Corporation was filed by the Department
  of State on the 2nd day of January, 1973.
- The Certificate of Incorporation of the Corporation is hereby amended to change the corporate name to HUAL North America Inc.

To effectuate such Amendment, Article First of the Certificate of Incorporation of the Corporation which originally read, "FIRST: The name of the corporation is AUTOLINERS, INC." is hereby amended to read as follows:

"FIRST: The name of the Corporation is HUAL North America Inc."
