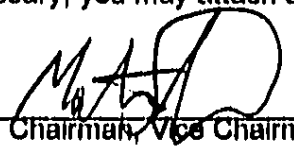

**Purpose Clause of
Masonry Industry Economic Development, Inc.**

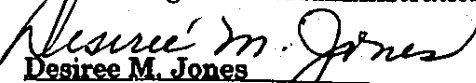
