

This is to certify, That we, the undersigned, do hereby associate ourselves into a non-stock corporation under and by virtue of the laws of the State of North Carolina, as contained in Chapter 22 of the Consolidated Statutes, entitled "Corporations," and the several amendments thereto, and to that end do hereby set forth:

- 1. The name of this corporation is, The Union Gospel Holiness Church of God, Incorporated.
- 2. The location of the principal office of the corporation in this State is at Lember of Gaston.
- as follows: For carrying on religious, missionary, charitable and educational work; and for the moral and mental improvement of men and women—especially of its members—by establishing churches and building houses of worship at any time and wherever the Church may deed it necessary and expedient for the promotion of the principles and objects for which the church is organized.






