The National Sash and Door Jobbers Association is a 501-C-6 Not-For-Profit Corporation and is Registered with the Federal Government as a Not-For-Profit Association. Our primary function is that of education to our membership and keeping them informed on any changes that might occur within our Industry. We do not sell products for the purpose of making a profit, nor do we engage in any retail operations, our function is similar to that of any other Trade Association sanctioned by the Federal Government as a 501-C-6 Corporation.

NSDJA did not actually commence business in Florida until after January 1996. We took possession of our building in December, began the movement of our office from Illinois to Florida, and commenced business sometime in mid-January 1996.

## THE ASSOCIATION AND ITS ACTIVITIES

National Sash & Door Jobbers Association consists of over 463 millwork and building products wholesale distribution centers located in forty-nine states. The area served by these jobbers covers eighty percent of the nation's population.

The association has 346 manufacturers and 211 manufacturers representatives as Associate Members on its roster. NSDJA will accept application for associate membership from qualified firms and persons engaged in selling to millwork jobbers.

NSDJA is organized to promote the use and increased consumption of stock millwork and related building products, including new products; to advocate and promote the sale of such products through sash and door jobbers; to perform such lawful functions that promote and provide for the welfare of the sash and door jobbing industry, and in general to aid the growth of the industry.

Member companies, in order to qualify for membership in NSDJA, must be in business for at least one year and must be primarily engaged in the wholesale distribution of millwork and building products to retail dealer customers. They must carry a warehouse inventory of products in sufficient quantity, sizes and designs to fill the needs of customers in their trading areas, maintain adequately staffed and equipped offices, maintain a full-time sales organization actively calling on the dealer trade and periodically issue a catalogue or price list covering products for sale at wholesale.
