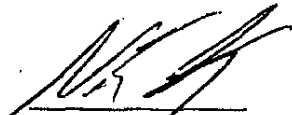

This Power of Attorney expires when revoked upon the completion of these filings and no later than October 31, 2008.

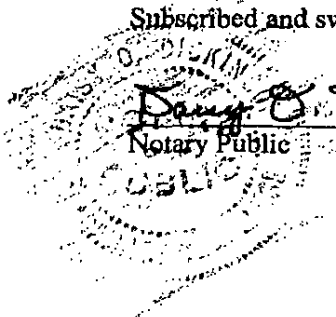
