Just before 5:00 pm I had to leave to go down to Palm Beach Gardens to attend our Network meeting, I told the customer how many copies he had made and that my associates would finish his transaction. After I left he made remarks that my Associate Dex should take care of the aids on his face. Dex did not understand the remark. He then wanted to know about a postal inspector because he did not trust the ONE in the back, referring to my Associate Michael, who's worked here for 5 yrs. This is not the first time this customer has started arguments when he is in the Store and always when I'm not here. Just before he left he made more remarks about Michael and this started an argument between the Dex and the customer.

the customer called and asked for the manager. I told him that was me. He started yelling and telling me I needed to fire the two HOMO's and that I had no business hiring or working with that KIND OF People. He made other remarks that I could not hear clearly. I told him not to ever come back into my Store. He said he would take it up with Corporate. I said fine and hung up.

this customer called my home asking for Longhorn Global Services (my legal name). My wife told him he had the wrong number. He called back a few minutes later asking the same question. She told him to call the store number. He asked her who the registered agent was; she told him she had no clue. He made some other remarks that she did not understand. She called me on my cell phone to tell me and I told her what was happening. My home phone is not connected to our corporate name so I don't know how he made that connection

I'm reporting this today because I'm not sure what this customer might due. My Associates are not gay. And this customer is defiantly a homophobic. Which makes me concerned for them and my Center?


