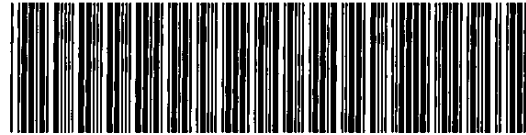

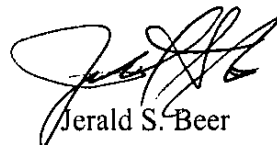

Pursuant to Florida Statute 607.1006 and Florida Statute 621.13, FERNANDO M. LOPEZ-IVERN, M.D., P.A., a Florida for Profit Corporation, organized and existing under the laws of the State of Florida, adopts the following Articles of Amendment to its Articles of Incorporation:

1. Article I of the Articles of Incorporation is hereby deleted and replaced with the following:
2. All reference to "Chapter 621" shall be deleted and replaced with Chapter 607.
